

Speaker details in brief

In 2014, I joined NMHSAG as a member and soon volunteered to help the Steering Group where we have had great success rejuvenating the group. Having represented NMHSAG on the Executive committee, I was elected as Chairperson earlier this year. My mandate is to help steer this group in the best direction for its future in this ever challenging and competitive climate for health and safety practice, knowledge, support and networking
Marcia Davies	Vice President of SGUK for over 5 years. Retired from HSE in 2011 after 34 years' service. Joined as an Inspector of Factories in the West Midlands and finished as Head of the Operational Strategy Division responsible for a wide range of Sectors. In between I worked in various operational management and policy functions, including work with European institutions. For 5 years I was Regional Director for the North West and subsequently Regional Director for the Midlands and London
Billy Gundry	I left school at the age of 16 following in my father's footsteps to become a coal miner. After 10 years, I joined the Mines Rescue Service gaining a wide range of experience whilst attending a variety of incidents including roof falls, fires, explosions, intrushes etc. In 2005, joined the Mines Rescue management team working through the ranks from a Sub-Officer to my current position as Operations Manager
Lee Bayliss	Lee is one of our associate Consultants specialising in Transport & Logistics having spent 30 years in the Rail Freight Industry working up through the ranks from the sharp end to the board room. Lee has spent the last 10 years leading complex change programs ensuring that people are at the forefront of any business change in rapidly changing markets and customer demands. Lee has spent several years as Safety & Operations Director for the largest Rail Freight Organisation in Europe. Lee's open, down to earth and affable approach helps him relate to employees at all levels within business and is a big lever in helping deliver business transformation. Louise Taggart	I spent 13 years working as an employment lawyer for a top Scottish firm. However, a personal tragedy led to my attentions becoming focused on the field of health and safety. I now tell my brother Michael's story in workplaces across many sectors and on major projects, including the Aircraft Carrier Alliance and Crossrail. My primary aim in doing so is to prevent others from losing their life or their loved one to a preventable workplace incident. I also carry out project work for the H & S charity Scottish Hazards, seeking to secure long-term funding for a worker's H & S advice centre
John Ainscow/ Ian Loftus	Training 365 in conjunction with the UK's market leaders in Electrical Testing Equipment, Martindale's, have designed a Safe Isolation Assessment programme to access competence in completing work on any equipment which is connected to a mains electricity supply following the HSE's new guidelines revised in 2016 (HSG85). This assessment has been nationally endorsed by the awarding body TQUK and provides assurance to both operatives and their employers that all work is being carried out meeting HSE regulations
Joyce Elisha	Joyce has worked in the field of Human Factors for 16 years and upon joining RyderMarsh OCAID has taken an interest in the important relationship between Human Factors and Culture. In that time, the main body of her experience has included Human Factors assessments of work arrangements in support of nuclear safety cases and providing structured estimations of the human reliability levels that can be expected from the quality of the Human Factors. Her role has provided extensive experience of cultural assessment and improvement in a wide range of industries (from manufacturing to research and development) by combining her knowledge of Behavioural Safety, Incident Investigation, Leadership and Human Factors. Joyce's motivation for working in this field comes from her conviction that the most effective way to help people is by encouraging and supporting them to take as much ownership as feasible through the provision of skills, praise and coaching because nobody understands a job better than the person who does the job
