Activities

Face Fit Testing - no one respirator will protect everyone!

Fit2Fit suggests that around 50% of respiratory protective equipment (RPE) is not fitted correctly so doesn't offer the wearer the assumed level of protection.

If it is decided to use RPE then workers could be at risk of developing occupational lung disease if their RPE doesn't fit properly, have purchased the wrong mask, are not trained on how to use it or is not inspected and maintained at required intervals. It is a COSHH requirement that wearers of tight fitting respirators (all filtering face pieces - disposable and reusable, half masks and full face masks) should have a Face Fit Test carried out:

- at the initial selection of the RPE
- at a change of make, style and size of RPE
- when there's an alteration in the wearers facial characteristics.



Fit2Fit accredited Face Fit Testers can ensure a consistent testing service across multi-site organisations, to ensure the RPE selected is adequate for the hazard and suitable for the wearer.

Operating Virtual Reality Equipment

Hire Association Europe's (HAE) VR project, known as 'V-Hire', has been developing over the past couple of years. The technology can be used with mobile phones with VR capability; using Samsung Oculus and Google's Android system as the development platform. The product will be launched initially in the Google Play store and available to use with the VR equipment, but later developments may well include broadening to other platforms, or even non-VR versions for use on touch-screen devices.

HAE aim to launch V-Hire during summer 2018 with 20 tool and equipment training modules included. These will cover topics including the Dangers of Dust, Working at Height, LPG and Electrical Safety, as well as numerous equipment tutorials on a variety of saws, compactors, drills, generators and many more. VR equipment is available when hiring tools from HAE members.
